PRESIDENT DYSERT: Thank you, Fran. You have heard the report of the Slate Committee. We will now proceed with the nominations for State Officers. There will be no seconding nominations for any office except that of President. A motion to close the nominations is not necessary.

At this time I call upon Deb Bingham, Past Exalted Ruler, Secretary, Marysville Lodge No. 1130, for the purpose of making a nomination for President of the Ohio Elks Association for the fraternal year of 201819.

MS. BINGHAM: I read fast, there's a lot. You probably heard him say "Not bad for a good old farm boy." Nevin has worn many hats during his life, first was farmer. He was one of nine children living on a farm in Hardin County where he learned the value of hard work at an early age. He graduated from Kenton High School and received his Bachelor's Degree in Agriculture Education from The Ohio State University.

His second hat was teacher. After college graduation he started his teaching career at Marysville High School, but spent most of his years at Fairbanks High School where he taught VoAg and was the FFA Advisor. During his tenure, his love of teaching was evident by the many ways he was active with the students, including serving as an advisor for

the Fairbanks High School High School Senior Class, National Honor Society, Mock Trial, and Prom Committee.

He was President of the Ohio Ag Teacher Association, was honored Nationally, as runner-up for Career and Technical Education's 2004 Teacher of the Year Award. During fair season he spent more than 20 years as sheep barn superintendent at the Union County Fair and Ag Superintendent at the Ohio State Fair. In 2011 he was inducted into the Ohio Agriculture Hall of Fame.

He was known to his students as "Coach" or "T" and was readily available to listen to a problem, help find a solution, and just be a friend. He retired from Fairbanks after 31 years of teaching. He taught several generations of families during his career. He supports the youth of today and believes the nation is in good hands for the future.

Nevin donned his third hat in 1982 when he joined the Marysville Elks Lodge. As an Elk he has held all elected positions, as well as secretary and treasurer. He was Exalted Ruler in 1989 and again in 2006. Was elected to Honorary Life status on August 6, 2008 and has been the Elks Scholarship Chairman for the past 20 years, including Educational Fund Grants and Most Valuable Student Scholarships. He is heavily involved in all aspects of Elks charities, especially the Ohio Elks State Major Project Cerebral Palsy.

As a Marysville Elks member of 36 years, he has won many accolades and awards, including Elk of year 1986 and 2005, Elk Hall of Fame in 1998. He was instrumental

in creating the James E. Payne Scholarship Committee that honors the memory of deceased Past State Member Jim Payne of the Marysville Lodge, who was the only other Marysville Elk Lodge member to serve, soon to be, serve as State President. Taylor recently received a Grand Exalted Ruler's Watch, which is the highest recruiting an Elk can achieve for bringing in 11 new members within one year.

Nevins fourth hat came with his marriage to Deana Pfarr, also a teacher, in 1985. That led to hat No. 5, Dad, with their five "kids" cats Leo, Thai, Sammy, Vincent, and Allie.

Nevin has enjoyed all types of sports. While at OSU he played rugby and football and is an avid golfer. His love of sports brought him hat No. 6, being a coach. During his many years of teaching he has coached and been an assistant in various sports, including football, volleyball, girls golf team, and girls softball team. He officiated football, basketball, and baseball games and retired as a wrestling official in 2006 after 25 years. He received the Central District Wrestling Association Official of the Year Award in 2005 and was inducted into the Ohio High School Athletic Association Hall of Fame in 2006. He is currently wrapping up his term as Ohio Wrestling Official Association President.

In 2002 he put on his Seventh hat as the member of Marysville Council for Ward 4, a post he has held for the past 16 years. While on council he has served as vice president and president, and for a few days Mayor. He enjoys watching the city grow and prosper, takes an active in the proceedings and is proud of the parts he has played in that development.

In 2013, Nevin became an ordained minister, hat No. 8, and he has officiated at numerous weddings and funerals throughout the state. He and his wife, Deana, are members of Trinity Lutheran Church and he assists there in various capacities.

PRESIDENT DYSERT: Sergeant, Sergeant at Arms, inform the Delegates, Representatives, and Members of this Association that I am about to reconvene the 120th Annual Convention of the Ohio Elks Association. Invite all within your calling who are duly qualified to attend this Session that they may participate in the forthcoming deliberations of the Association. You will see that unnecessary noises will cease immediately and at all time preserve order and quiet so that nothing shall disturb the proceeding of this session.

MR. ROPP: Mr. President, your order has been obeyed. PRESIDENT DYSERT: At this time I call up the Chaplain, Greg Goodballet, to lead us in prayer to be followed by the Pledge Of Allegiance.

(Invocation and Pledge Of Allegiance)
PRESIDENT DYSERT: I now declare the 120th
Annual Convention of the Ohio Elks Association and
Benevolent Protective Order of Elks of the United States of
America reconvened and in session and shall proceed with the
regular order of business. I ask that all present to please turn
off electronic devices so not to disturb the proceedings of this
Session. If by chance any do sound there will be a \$10.00 fine
levied with the proceeds going to the State Major Project.

The Dignitaries at the front, to my left, were introduced yesterday at our Opening Session. I'm sure you will be hearing remarks from these fine representatives later this morning.

I remind you that any business requiring a vote only Exalted Rulers, Past Exalted Rulers, Past State Presidents,

Officers, Delegates, and Alternates may cast a vote. A "D" stamped on your registration badge designate your voting right. If you have any questions concerning your credentials, please see the Credentials and Registration Chairman. Also any member who wishes to address this session should advance to the microphone and speak into it, giving your name and Lodge number so that all may hear your message and it can be recorded. I ask that each chairman please stand when your State Officer introduces you and your chairmanship. No reports are to be read from the Committee Report Booklets. If there is anything that you would like to add to your printed report, it can be done at that time. Any chairman having trophies, plaques, or certificates to be presented and pictures taken following this session.

I now call upon Second Vice President, Tom Pavlik, for the reports and committees under his jurisdiction.

MR. PAVLIK: Thank you, Dane. The first committee under my jurisdiction and the assistance is Webmaster, Larry O'Grady, Elyria Lodge. I don't believe Larry is with us. Larry has done a fine job over the years as our Web Master and he is stepping down. And I believe, and if I'm incorrect, please correct me, Richard Threadgill and Kermit Morse will be taking over. Thank you for that.

Second, is our State Recorder, Lori Delhees, PER from Port Clinton. Lori works tirelessly to the right of us up here two times a year. She makes sure everything is recorded. And as I've said this in the past, since I'm also the secretary of the IGB, my fingers would fall if I had to do what she does. So

MR. GONTERMAN: Thank you, Tom. I thank all the Officers, I'm going to start out with, and it's the first year that all of our main officers have reported their youth activities. You want to give them a hand. (Applause) And our Grand Lodge Sponsor has reported also. Not so well with our committee chairman of the organization, where only about half of you have reported. Also, I have two Lodges that have not reported any to the Grand Lodge and the deadline is May the 1st. And those two lodges, it's unusual for me, but I'm going to name them off, East Liverpool is one and the other one is Columbus/Grove City. And neither one of them has reported anything the entire year. I would like for those two to report to give me 100 percent. They have caused my problem of not having 100 percent and I do not appreciate that. And all of the committee chairman, please help me out next year, I've got another year at it and I'd like for you to make 100 percent. The ones that did report have done an excellent job and I thank all of you. Thank you.

MR. PAVLIK: That concludes my Committees, Mr. President.

PRESIDENT DYSERT: Thank you, Tom. I now call upon Trustee Member, Ed Connors, for the report of his committees under his jurisdiction.

MR. CONNORS: Good morning. The committees in which I I'm not in charge of, but I'm their go-between, if you would are several. The first one is Americanism, chaired by Debbie Lazar, Past District Deputy, Bucyrus No. 156. Debbie's report can be found on Page 3 of the program. Deb, are you here? Anything more to add?

MS. LAZAR: Just real quick. If anybody has the name on this page, if your lodge does, come see me, I have a winning gift card to give you.

MR. CONNORS: Thank you, Deb. Secondly, and this one is crucial and important in today's times, Drug Awareness, chaired by Gary Wadlow, Past District Deputy, from Salem 305. Gary's report can be found on page 10. Gary, anything to add?

MR. WADLOW: Nothing to add.

MR. CONNORS: Okay. Thank you. Next is Membership/Lodge Activities, Past District Deputy, Tom Pavlik, Ashland No. 1360. Tom's report can be found on page 13. Tom, anything more to add to this?

MR. PAVLIK: The only I'd like to add, I will be stepping down as chairman and Chris Hatcher will be taking over. Please support him the best you can. We all know that retaining and gaining members is getting harder and harder.

MR. CONNORS: Congratulations, Chris. I'm sure you're going to do a great job.

Next, National Foundation, Mary Carolyn Nichelson, Ohio River Valley No. 231. Her report is on page 15 and go for it.

MRS. NICHELSON: Thank you very much. I stand before you a very, very happy camper with Ohio this year. As of yesterday, and this changes right now about every Friday. We are in grants for Ohio at \$359,485. Whaa Hoo. That's like \$100,000 above what my goal was. And if you got my communication from last week, there still, I believe 17 lodges now who are eligible or at least \$2,000 for a Gratitude Grant. If you made your GER's goal at the very end and you think, "Well, can I still get that grant"? Yes. You have until May 31st to apply, until August 31st to use those funds. So that's almost \$60,000 Ohio would be leaving on the table. I can't thank you enough. Anniversary Grants, how many in here their Lodges got them. Unbelievable. Unbelievable. Just lodges that never ever got a grant before got Anniversary Grants. They will be available again next year.

There are many, many changes coming in ENF over the next two years. And I can tell you when I do the workshops at the National Convention the one thing they always tell us is they're not going to stay the same. They're going to be changing, improving, so you have to keep up on educating yourselves and Lodge members and especially you chair people on what is new in ENF. I'm doing a workshop today; I had to study the new changes. And there will be changes in next year and then changes the year after that. And essentially what they're trying to do is align the Grants with the Lodge year. Thank you, Jesus. So it's going to take us two years to get into April 1st as being when you apply for the Grants. But next year will be a bit of a it's going to be just a little

different and then after that it should stabilize with the grants instead of having one due here and one due there. So come to my workshop and we'll discuss it. Please do yours online. Secretaries and ENF Chairman be sure, we're going to talk about online donations too.

Now, I'll get on with my daily program. Usually I give out plaques in August, because the numbers at our State Convention have not been stabilized. But because our convention is so late this year I was able to get the winners in the categories as we have some just fantastic things to announce today about some of our winners.

Secondly, Rose Durant has donated, once again, a beautiful mug and pitcher set. If you can't see it, please stand up. Lee, who is a collector, tells me the purple is the most desirable of the colors to collect. I went online and I found one set and it was on EBay for \$1,750. So this is quite a keepsake. And whatever, who wins it, whatever you do with it, display it at home, display it at your Lodge. Run it on another raffle for ENF, whatever you want to do. But we still have raffle tickets for sale, Lisa in the back, if you want them; they're \$5.00 a piece, 6 for 20. So if you want them, a lot of you already have them, we sold quite a few and I thank you for your generosity because your Lodge doesn't get credit and don't get personal credit. That is being truly generous and I appreciate it. And I know this will be a couple thousand dollars that ENF doesn't have to raise in Ohio, so thank you in advance for that. We'll do the drawing; I think we'll just wait until the end of the meeting. If anybody wants tickets, you can

raise your hand and Lisa Wadlow will be coming around.

Now, let's see. I think we need to do our presentations. When I call your Lodges name, if we could have the ER and the ENF chairperson, the ENF chairperson from your Lodge come up, or the ER, or whoever is here. Yes, somebody come up. What we're going to do, I'm going do the per capita first. In 5th place, with a per capita of \$16.72, Elyria Lodge No. 465. Anybody here? All right. Oh, they're at Ritual. Sure. Thank you. In 4th place, with a per capita of \$18.49, Berea Lodge No. 1815. In 3rd place, with a per capita of \$20.80, Marysville Lodge No. 1130. Yes, Kermit. Congratulations. Thank you. In 2nd place, with a per capita of \$23.48, Willoughby/Cleveland No. 18. Yes. Congratulations. Give me a hug. And in 1st place again, with a per capita of \$28.80, Gallipolis Lodge No. 107. Wow. He's last year's ER, so he was the one that won it.

And our Chairman Challenge, in 5th place, with 101.1 points, Wooster Lodge No. 1346. The Chairman Challenge is for the Lodge Chairman and how they accomplish the year. Making the GER's goal, retaining members, doing the online education, retaining new members from last year. They get points for all of that and 101 points is significant. Thank you. In 4th place, with a 101.4, wow, that was close, Ashland Lodge 1360. Congratulations. Great job. In 3rd place, with 137.35 points, Marysville Lodge 1130. Yes. Good job, Kermit.

Okay. Now the next two were not only State Winners, they also placed Nationally. That's a big deal. And Gallipolis

Lodge No. 107 with 145.2 points came in 2nd place in our state and 2nd place in the nation for Lodges of 700 or more members, so that is fabulous. Congratulations. You'll get a plaque in San Antonio too. And in 1st place, in the Chairman's Challenge, and in 1st place in Lodges 301 to whatever the next number. 1st place Nationally, 1st place in Ohio, boy, that says a lot about Ohio, doesn't it? Toledo/ Sylvania Lodge No. 53 with 156.1 points. Wow. This is quite an accomplishment. And when we score something in the top of the United States, and 2nd, it just says so much. Thank you so much. So let's give all our winners a nice round of applause. Now, does anyone have any checks? Please make sure you don't give me the CP checks. Well, that happens every year. Thank you so much. Fremont Lodge \$908. All right. Thank you. Willoughby/Cleveland \$300. Ravenna, \$531. Wow. Salem, \$1,000. And Berea, \$304. Thank you all so much. We'll do the drawing right at the end. If you don't have your tickets run back to your room to get them, because you do need to have your ticket to win. Thank you.

MR. CONNER: Thank you, Mary Carolyn. Mary Carolyn, your Session is what time?

MS. NICHELSON: 2:30.

MR. CONNORS: 2:30. In which room?

MR. CONNORS: Thank you. Next Committee I have is Veterans, Past District Deputy, Brad Goodballet, from East Liverpool No. 256. Brad's report is on page 18. Brad, do you have anything to add?

MR. GOODBALLET: Thanks, Ed. First of all. thank you to all of veterans that are in the room. I received an email from the Kentucky Speedway regarding the NASCAR series. For the weekend of July 12th through the 14th they're offering a 50 percent discount to all veterans. So anybody that's interested, please contact me and I'll give you the information. Deb, Cincinnati VA Hospital, this is a good opportunity for a field trip. Again, that's the NASCAR series Kentucky Speedway July 12th through the 14th. We are going to continue our bags that we pass out for the veterans. We pass them out in April and we ask that you return them full in August, and the bags will be available outside the door after the meeting. We're asking that you fill them with underwear, T-shirts, and socks, all new items, unused, and we also ask that if you take a bag that you return it in the bag. The bags serve a dual purpose, as reminder for you, but they're also used the veterans also use them to carry their belongings around in the hospital. So if you take a bag, please return the bag. If you like to buy the bags, we can sell them to you also.

In August I spoke to you about the most important commodity that you could give to the veterans, and that's your time. And I'd like to read a poem for you.

"The joy you bring to all of us will be remembered long after you're gone". That's the title. "There are a lot of veterans much happier. Why? Because you volunteered your services today. You talked with them with kindness, tended their needs with pleasure and with ease. Like only you can please. The day slips by so fast and you have to be on your

way. You know that well say a lot of kind words of you and give thanks for the help you gave us today. There are a lot of hearts rejoicing over what you did and said. The man whose hopes were fading now with courage looks ahead. You might think your day was wasted, but to us it was well spent. You spread a lot more kindness than you will ever realize. And we close our eyes in slumber, we will pray that God will say, You have earned more tomorrows for a lot of volunteering work today and we will look forward to seeing you another day". This poem was written by Lyle Hancock, U.S. Army Air Force Sergeant, World War II, 1944-1948, and he was a resident in the Cleveland VA Hospital for 20 years. Thank you.

MR. CONNORS: Thank you, Brad. Lastly, the last two I have, is I answer to Past State President Doug Schiefer, who is Chairman of the Grand Lodge Fraternal Committee, from Bucyrus 156. Doug, do you have anything to add?

MR. SCHIEFER: Later.

MR. CONNORS: Later. Okay thank you. And lastly, the Memorial Service, which will be held later this morning, Chaired by Harold "Red" Kehler, Past State President, from Elyria 465.

MR. KEHLER: Just a quick reminder, that the Memorial Service will be at 11:00. One significant change this year, the PER Association will be participating in this service and will read the roll call of the departed PER's in the state. I don't know if it's the first the time this has been done, but it's the first time in a long time that it's going to be done. So please take that in mind and participate in this worthwhile

service. Thank you.

MR. CONNORS: Thank you, Red. Mr. President, that is the combination of the committees under my jurisdiction. Thank you.

PRESIDENT DYSERT: Thank you, Ed. I now call upon Trustee Approving Member, Lugene Ignaffo, for the reports and Committees under his jurisdiction.

MR. IGNAFFO: Good morning. Thank you, Mr. President. I have the pleasure of working with some very hardworking Elks throughout the year that sometimes we forget all the stuff and the time that they put forth to get their committee work done and their how should I say it? their obligations done that they feel that they owe whenever they take that committee. So first off, I work with Lodge Operations, which is Chaired by Dean Streit, he's a Past District Deputy from Wooster Lodge. His report is on page 13 in the booklet. Dean, do you have anything to add?

PRESIDENT DYSERT: He's next door.

MR. IGNAFFO: He's next door. Okay. Moving on. The next one is Registration and Credentials, also that's Mr. Robert Essig, from Ashtabula Lodge. He's a Past District Deputy. His report is to be given. Robert.

MR. ESSIG: I will have the final report available at tonight's session.

MR. IGNAFFO: Thank you. Now, the next one, the big one. We all know that the Stanley's work very hard on Conventions and Reunions. I don't think I've ever seen anybody work harder to appeal and please everybody in the

crowd. If there's a need they find a way. If there's a want, they find a way. But we all know that Linda runs this, right? And that's Past State President, Past District Deputy, Mike Stanley. Like I say, Mike and Linda, they do a diligent job and I don't think we could ever thank them enough. I'm glad they're in charge of this and not me.

MR. STANLEY: Lugene, I could have told you that. Okay. My report is on page 10. The Grand Lodge Convention is coming up July 1st through the 4th, San Antonio. We'll be at the Emily Morgan Hotel; again, we'll be the only state there. I guess when you don't play well with others they put you by yourself. So we've received about 90, I think 91 reservations so far. On the reservation form there's a place for you to indicate if you're the Exalted Ruler or Alternate. We have 77 Lodges and I have not received a reservation form indicating the Exalted Ruler or the Alternate will be going from Alliance, Ashland, Barnesville, Bellevue, Berea, Bucyrus, Chillicothe, Cincinnati, Circleville, Columbus North, Conneaut, Coshocton, Cuyahoga Falls/Akron/Barberton, East Liverpool, Elyria, Fremont, Greenville, Hamilton, Hillsboro, Ironton, Kent, Lexington/Shelby, Mansfield, Marietta, Marietta, Massillon/North Canton, Toledo/Sylvania, Warren, Washington Court House, Wellsville, and Willard. 30 Lodges I have not received anything from. The rooms are filling up fast. If you look on that reservations form, the deadline I need to get those is May 11th. People, that's only 13 days away. So unless you're planning on taking your pup tent with you, I suggest you people, which if you're going, let's

get those reservations in. I know July 1st seems a long way off, but you need to get those in. One thing I want to mention is, Alternate to the Grand Lodge Convention. If you are the Alternate to the Grand Lodge Convention, the duly elected Alternate, you need to, your Lodge needs to send a letter to the Grand Secretary informing him that you, Pete Jones, the duly elected Alternate from whatever Lodge you're going to you'll be attending, that person will be there. And then when you go that Alternate has to take a copy of that letter and present with it your registration card when you register. Even if you preregister you still have to show them your registration card. You have to give them that. The reason being is, you have to have an Alternate or an Exalted Ruler there to count that your Lodge had the representative. You can have all your Lodge officers go. You can have 100 PER's be there, but those are the only two people the Grand Lodge recognizes that the Lodge had a representative there. If not, your Lodge will show there was no representative there. So make sure they get those letters into them.

The District Deputies, I didn't make your clinic yesterday, I got tied up. Just to remind, if you put together a schedule for your workers, make sure I get a copy. Gary because I've only got one schedule so far and Gary Stevenson, thank you for that.

Pins and patches. We have the new pins for this year and, of course, we're still selling the patches for the Blazers. They'll be available after this Session outside the door right here. And the shirts, Convention shirts for Grand Lodge will

be on sale this afternoon out there as well, so I wanted to remind you of that. With that, I'll leave you with A minister was giving a sermon on forgiveness, and he said, "Everybody whose forgiven their enemies raise your hand". About 70 percent of the people raised their hand. He looked around, he says, "I'll ask again. Everyone who has forgiven their enemies raise their hand". Everybody in the church raised their hand, except way back in the way, Old Ed Johnson sitting back there. Well, Ed, he's kind of a cantankerous old, guy, never been married, and 96 years old. He said, "Brother Ed, would come forward". Ed came forward, and he says "Ed, why haven't you forgiven your enemies"? "That's easy, I outlived all the assholes".

MR. IGNAFFO: Thank you, Michael. Like I say, without the dedication of Mike and Linda, too, at the Conventions and Reunions, we'd probably be in chaos sometimes, so please let's show our appreciation for their hard work they've done this weekend and the upcoming.

Well, I have the honor of doing two other committees that I work with, but they don't fall under a chairmanship except for me. So at this time, I would ask if I could defer that final report to this evening.

Mr. President, that would conclude my Committees under my jurisdiction.

PRESIDENT DYSERT: I now call upon Trustee Chairman Mark Ratliff for the reports of the committees under his jurisdiction.

MR. RATLIFF: Thank you, Mr. President. Good

morning, all. I have the pleasure of working with six committees of the Association this year. The first one is Bowling. That's chaired by Keven Knight, from Toledo 53. The tournament just recently ended, so, Kevin, do you have anything to add?

MR. K. KNIGHT: I do. Most of you have put up with me last night, so I get to keep it nice and short this morning. This year we had 19 Lodges represented at the State Tournament. The year before we had 28. Quite a few Lodges have just suddenly fallen off the earth and I'm going to need your help to try to get the word back out to these people. I have 450 members throughout the state to whom I send emails out to about once a month giving them updates on the Tournament, but the number keeps dwindling, because people sort of drop their emails and so I can't get the word out to some of your Lodges. So come this fall I'm going to ask all your help, I'm going to send something out. I don't know if you have like Toledo has, with an E-Blast or something of that nature, but if you could put a blip at least in your paper it's going to help.

A year ago you folks remember me standing here begging you to host a tournament. Nine Lodges stepped up and said "We're interested". The only problem is five of them either don't have bowling alleys or don't have bowlers, so it kind of makes it a little bit off the edge. This year I started a couple of new things. This year we had a Veterans Award for every event, every week, giving them special awards honoring our veterans. This past year we had a little thing we called the

Homewood Daily Double. You got to pick out your own horse. In other words, you got to pick any bowler you wanted, put your money on his back. It didn't mean you had to give to the horse. Well, that helped raise quite a bit of money this year for Cerebral Palsy. I want to really thank Lakewood. They stepped up this past year, it's their 100th Anniversary, let's honor them for their 100 years of service to Elkdom. But I want to thank them for all their work for me.

Next year we're in Kent. We're going to start a week early, which means I hope my new boss get's the cha wherever. I hope you'll be able to make it this year; we are starting a week early so we don't conflict with basketball or with Hoop Shoot. Now, real quickly, I'm going to read off the list of Lodges, please see me before you go home. I have checks for your bowlers or I have trophies and checks. So the following Lodges, Lorain and by the way, that big trophy out there is yours, so I hope you took a vehicle, the right size Troy, Ohio; Bellevue, Sandusky, you got a trophy coming, too Circleville, Coshocton, Springfield, New Philly, New Lexington, Nelsonville, by the way, Nelsonville, just to let you know, you've got a group of people is anyone here from Nelsonville today? No. Well, Nelsonville has a team I'm honoring them this year. They come every year. These people don't know how to bowl. They have no clue. Five bowlers the first game shot a grand total of 505. Don't chuckle, they're back every year and they're probably one of the happiest groups to be at a fraternal organization event. They come back every year, that's sportsmanship anyway, Mt. Vernon,

Athens, and Barnesville. So I'm trying to avoid sending checks through the mail. Please see me before you head on home. A few of you already know you've got envelops coming. So thank you. I'm cutting it short.

MR. RATLIFF: Thank you, Keven. The second committee is Golf, that was chaired this year by Brian Saterfield from Galion. His report is on page 11. Brian isn't with us this weekend.

This year's Tournament will be held the second weekend of September. It's hosted in Ashland this year, so I'm sure there will be more information coming. Ernie Weiler from Ashland will be the State Chairman, so look for things from Ernie coming out soon.

Next is Charity Tickets, that's chaired by Lloy Skillicorn, from Galion. His report can be found on page 8. And he's making his way to the front, so he has something to add.

MR. SKILLICORN: First off, if any Lodges need more tickets than what you got this year, just send me the email and let me know how many more you need so that I can add it and I'll get them to you. The following Lodges I need tickets from: From the North Central District: Mount Vernon; Northeast: Conneaut, Barnesville; Northwest: Defiance, Swanton; South Central: Circleville, Ironton, New Lexington, Nelsonville, Southeast: Cambridge, New Philadelphia, Barnesville; and Southwest: A whole bunch, Springfield, Hamilton, Washington Court House, Middleton, Hillsboro, and Wilmington. Thank you.

MR. RATLIFF: Thank you, Lloy. Next up is

Calendars, that's chaired by Duke Miller, Past District Deputy Grand Exalted Ruler from Painesville. His report is on page 4. And Duke also has something to add.

MR. MILLER: Yes, just a couple, just an update, because the March results are in. And I guess it's kind of a good news/bad news thing. The good news is, we've increased our Calendar sales 624. We've sold 4,643 as of the end of March and as there will still be some more trickling in April. The bad news, I was talking to Lee this morning and he said we're paying out a lot more money. So that's bad news for the Ohio Elks Association, buts' also the good news for you. And I guess that's all I got is good news today.

Just to update my report, as of the end of March the Northwest District has sold the most calendars with 1219, followed by Southeast with 1,023, and Northeast 842. Ohio River Valley, Mercy County, and Lima are still the top three Lodges.

We had a good year this year. I want to thank everybody that helped sell calendars. If we can keep this up, we can keep increasing it; make more money for the State and more money for all of you out there. And that's really the good thing. If you look at the list that comes out every month of the winners, the Lodges that have sold the most calendars appear on that list more times, so you need to sell more calendars to get more money out to your members. So thanks a lot for all your help this year and hopefully next year will be just as good.

MR. RATLIFF: Thank you, Duke. Next up would be Cerebral Palsy, that's chaired by Cindy Rinehart, from

New Philadelphia. Cindy couldn't be with us this weekend, for a family obligation. I'm going have Chuck Hilyard and Sara Dunavent please come forward, they have some check presentations. Cindy's report can be found on page 6. And I will turn it over to them.

MS. DUNAVENT: Thank you. If I can have the reps, the CP reps from North Central come up, Northeast, Northwest, South Central, Southeast is she's already got hers, and Southwest, which is myself. Northwest we gave to the Ability Center of Toledo, the Sunshine Foundation, Sara's Garden Hyperbaric Center, Children's Development Center of Lima, and Mercy Health St. Rita's Development Therapy, for a total of \$51,114. North Central, we gave the Mercy Health Foundation, Fairway/Waycraft, Wayne County Committee for Crippled Children, Fisher Titus Medical, for a total of \$31,500. South Central right? That's a big list, Easter Seals Rehabilitation, Ross County MRDD, Gallia Board of DD, Guiding Hand School, Jackson County Board of DD, which is Hope Haven, Vinton County Board of DD, Meigs County Board of DD, Perry County Board of DD, Union County Board of DD, and three camperships, for a total of \$50.172. And I also have checks for Northeast, which is UCP of Greater Cleveland and the Hattie Larlham Foundation, sorry, I don't how to say that, for \$31,790. Cindy has the Echoing Hills Village, Ewing School, Belco Works, Rainbow Connection, Jefferson County Board of DD, Guernsey County Board of DD, I think it's Bellaire Elementary School, and two camperships, for \$29,800. And finally, the Southwest, United

Rehabilitation Services and two camperships, for total of \$20.800.

This year through your hard work we were able to give out a total of \$215,176 in grants and camperships. Thank you all for your hard work. I have the District O.S.U. Tickets out at the booth. District reps, please see me. And please, everybody, encourage people to purchase those, it's two season tickets for Ohio State home games. We also, on behalf of the CP Board, are going to donate 100 lanyards to the veterans for use at Sandusky. There's a 50/50 raffle going on out at the booth for proceeds going to the Endowment. And Chuck has one other thing.

MR. HILYARD: Good morning, everyone. I am the CP Fund Committee Treasurer, so I do have the final results for your 2017-2018 year. So this is the results of, I'm going just read the Districts, the North Central District, their per capita ended up being \$6.68, and they only had to meet \$4.00, so there's some big totals there. The Northeast District finished at \$7.13 per member. The Northwest District a \$5.66. The South Central District at \$6.46. The Southeast District at \$3.68. And the Southwest District at \$2.30. So all in all we did a very good job as a State. We did \$5.36 overall, so well above the goal, so our congratulations to, for sure, all the CP reps in each District for pushing CP, and again back to the members for donating the amount that you did donate this year. Did want to call out a few individual Lodges that were in double digits, so if you could bear with me real quick. The North Central District: Norwalk \$17.43 was their per capita.

apologies.

MR. L. KNIGHT: We'll accept it. As he said, this is Roger Martin's Report, and his report can be found on page 6 of the directory. I'd like to add, that because of your generous donations and support we have helped to make significant contributions to the State Major Project Endowment. The state Major Project Board of Directors and the Fund Raising Committee truly appreciate your support on behalf of the Endowment. We will be holding another fundraiser raffle again at the Fall Reunion. It will be similar as to last year, well be selling raffle tickets and accepting sponsorships for the 8 major change in prizes. After listening to comments from last year we have made a couple of changes. We will be moving the start time to 7:30, Jim, so that Jim and the Grand can be there, through to 7:30. And the raffle and the other items we will have other items, as well as selling chances on door prizes, which will also be accepted for donation. All the information and tickets have been put in envelops to each Lodge and should be picked up in the registration room. Did everybody pick them up? This will give us more time to sell the tickets and sponsorships for this year. Again, thank you for your continued support of the Endowment. Roger Martin, Past District Deputy, Past State President.

Again, I hope everybody has picked up their packet in the registration room, if not, please do. Get those back to your District and sent out to your Lodges within your District.

Form New Lexington 509 for the CP Trust, \$3,500. Finally, the Bowling Tournament \$450. Thank you everybody.

MR. RATLIFF: Thank you Sara and Chuck. The last committee is our State Major Projects, that's chaired by Roger Martin, Past State President from Hillsboro. He decided he wanted a little more sunshine and went south, so we'll refer to Lance Knight, Past State President, from Lakewood or Lakewood. I guess I should have got in earlier last night. I know that we're always asking for more and more and more, but this is the future of the Ohio Elks Association so that we can do better and greater things not only for CP, but it is the Ohio Elks Charities Endowment. So down the road if there's another charity that we elect to give to, we hope that we can support those endeavors down the road.

The next thing I had, again, we will be having the Fall Raffle and we will be accepting Sponsorships for that raffle,

Three of the services can be done in the public, so it's not just in the confines of the Lodge meeting. We did have a change in the funeral service at the beginning of this due to the fact that we wanted to clarify some of the opening of the funeral service to make it that we wanted to show the family members how we as Elks honor our deceased members there. If you have any ideas for a special service, because all three of these came from individuals like yourself, get with the area committeemen, which is me in this case, and we can discuss it and then put together the form of how to do a special service. That's how the POW/MIA and the Veteran's Days Service come along. So you have an idea or something you want to do, contact us. If you have any ideas for Rituals, because we're, besides the initiation as the special services, we handle all Rituals in the Elks. And basically oh, the winners will be announced tonight at the meeting of the Ritual Contest, the chair the team winners and the chair winners. I do have some more chimes left of my last group of chimes, so if anybody wants those little chimes, you see me, we can get that. And anything else I can say is God Bless, God Bless the Elks, our Troops and first responders, wherever they may be, and God Bless the United States of America. Thank you.

It will work in the future. It is going to be wonderful, as I say, after you and I are gone.

I've got if great news. I've got some congratulations. Before I introduce Ed and introduce Penny, I've got to tell that you we have good and bad news too. And I want to make sure that you understand that we're going to San Antonio, kind of a destination city, and you really want to take your family to it. And although it's not warm in July in Texas, San Antonio has this water down below the level of the streets and it's very pleasant and it's going to be a great crowd. We're celebrating our 150th Anniversary in a big, way, especially during the Opening Ceremonies in San Antonio, so go, I guarantee you'll have a great time. Okay. Now, good news and bad news. The bad news first, we lost 551 members in the state last year. The good news is, that's half of what it was last year and that's a third of what it was two years ago. Are we going in the right direction? Yes. Not quite good enough, but we're going the right direction on membership, and that ties in with our thanks on grants and all of that kind of thing.

On Membership, Exalted Rulers, put every single one of your officers on the Membership Committee and make that

you.

PGER NICHELSON: Oh, okay.

PRESIDENT DYSERT: James L. Nichelson, from Ohio River Valley Lodge 231, who will introduce our Special Guest.

PGER NICHELSON: In a minute. When I started college at Ohio State I had the distinction of being cussed out by Woody Hayes on my first day there. A true story. I lived in the stadium dorm and in those days the team watched films at night, and I walked through on my first night and tripped over the cord, and Woody who said "Who did that, blah, blah, blah, blah"? We got along a lot better after that first night. But Woody always said something that I have found to be very true, and that is "Pay it forward". And that's what we started to do, my friends, with paying it forward with a fund that we are establishing for posterity. And Lance said it so eloquently; this is not necessarily a CP fund, although right now it really is. But right now it's not paying anything. We're trying to grow our Endowment. It's over two million bucks. A couple of things have not been said about it. You should understand, although the Market is going up and down and it's crazy right now, the conservative way that those funds are invested, and so you know, so everything is transparent, right now it's 55 equities and 45 fixed assets. That means stocks and bonds. That's fairly conservative, so we're in it for the long run. This is not anything that should get you terribly upset, even though the Market right now is crazy. And we're all going to be dead and gone before our annuities, or whatever we invest

Committee work. Here's what you do: Get your list of folks who have dropped, maybe for the last three, four, five, six, seven years, and you sit down as a group get out your phones and call them up and say "You know what, we really miss you. We need you. Would you consider rejoining"? People who do that get 50 percent return satisfaction reinstatements. Do it. Exalted Rulers, every officer, every officer is on that Membership Committee, call them up and say "Hello, we want you back". You will get a 50 percent return. That 551 will go away and you're still in the 60 days where it's free.

Okay, wonderful news on Grants. Everybody, except 6 or 7 Lodges what is it, 6 or 7, Mary Carolyn? got a grant. We use them in the community. We now use them for membership. We're not selfish we'll give money in our community, and "Oh, by the way, we're a Lodge that is involved in our community". And "Oh, by the way, if you like what we do, come join us". Use it for membership.

Do it as soon as you get home.

We've got a couple of folks who are gracing us with their presence to visit us from Michigan, Ed and Penny has been here before, I think you probably know them. But it's my very great pleasure to introduce to you Ed and Penny Geishert. Ed is, of course, Public Relations and Marketing and Membership and all of that, and he's going put on a CLMS seminar this afternoon. I think I heard 2:30, did I not? And probably in 4. I'm not sure where it is. But definitely if you're interested in CLMS and all of that, come on over to it. Ed also has a stake in membership and that's what I'd like him to talk to

you a little bit this morning. So without further adieu, please welcome Ed Geishert.

MR. GEISHERT: Thank you, you very much. I have to compliment you on your good manners, by this time in Michigan the room is half empty, and there's been a mass exodus for the door.

I do want to tell you before I begin, I've listened to the Chaplain closely this morning, so I've taken two pages out of the middle the end is coming quickly.

10 years ago I was appointed to the Public Relations Committee. At that time our focus was Public Relations, getting press releases out to the newspapers, getting something in print. We didn't care much about we weren't focused on membership at that time. For dozens of years Grand Lodge did us a disservice, "More members. More members. Cattle drives. Bring them in. Bring them in". It took us a long time to turn around and look and saw that we had the back door open. We were recruiting members like the devil and we're getting vast members in and they're working their way out through the room and out the backdoor. A couple years ago we closed that door. We started working on retention. We started working on getting delinquent members back. Keeping the members that we've got. We're already invested in these people, let's keep them with us. Let's keep them here. Let's get them busy.

There's three parts to getting a new member. First the application, you ask them. Easy enough. Okay, we've got their application fee. Now we have to do something

with them. We orient them. I believe this is the weak link between the initiation and the recruitment, is that orientation. Teaching new members who we are, what we do, and telling then what their rights and obligations are. A new member has an obligation to the Order. We are a fraternal service organization. We do work in the community. Thanks to ENF we're being recognized more and more for the money we're working into the communities. We're getting the recognition slowly that we've deserved for so many years. Orientation is where we teach the new candidates about who we are and what we do. Penny and I have visited probably a thousand Lodges across the country. We speak with a lot of State Officers, a lot of Exalted Rulers, Lodge Officers, Club Managers, and bartenders. Way too often we find that an Indoctrination and an Orientation Program is an hour before the meeting. The meeting is at 7:00, we meet at 6:00. Yes, we tell them about what we do, show them a video, and then we initiate them. We've got them in. I don't think that's the way to go about it. And an orientation needs to be set on a separate night, it should last at least an hour. Penny and I have been doing it for 30 years. We get new committee people from the candidates during orientation. We give them a list of all the committees, what the duties of the committees are, the approximate time it takes throughout the year, by month, day week, and we get them to commit right there. There's something on that list they want to do. They want to work with veterans. They want to work with youth. They like the scholarship idea. There is something there for them; we just

have to pair them up. I'm going to hand these sheets out at the CLMS Workshop. CLMS Workshop in Dublin 3, right over here at 2:00. They said that the CLMS Workshop, it's more of a secretary/officer's workshop. We're going to cover the secretary's office entirely. We're going to tell to you shortcuts, the duties. We're going to teach you to be a good secretary without the least amount of effort. Combined, Penny and I, have to 28 years as Lodge secretaries so we know the ins and outs, we can help you a lot.

Grand Lodge has helped us in a number of ways over the past year. They've change some rules. They change rules so now we can initiate people within 30 days. That's the 30 day rule. From the time that application is read on the floor until they're made a member should be no more than 30 days. They allow us now to notify the membership by posting on a Lodge bulletin board. It doesn't have to be printed in the bulletin anymore, it can be. But if you're going to meet that 30 days post it on the bulletin board. Membership retention, the most important part of a Lodge's activity right now is with new members. We don't have trouble getting them in, it's keeping them. As a CLMS coordinator I have access to the databases of all the Lodges in the country. I particularly look at Area Four. Before I came here I was going through Ohio's Lodges and I'm looking at your delinquent list. I'm amazed at the number of members you have on the delinquent list that are 40 and 50 and a couple of 60 years members. I wonder, did you really know where these people are? A 60 year member, think about that, if he's initiated when he was 21 he's in his

Is he in a nursing home? Is he in Veterans Home? Find out where these people are. Use Legacy.com, which will give you an obituary of a person anyplace in the country. And maybe that member is already deceased and you're paying per capita on him, you don't know. If they're in a nursing home or a veteran's home the chances are their kids get the mail, they're not going to pay Elks dues, "We're not going to pay that. 100 bucks this year. He's not ever going down there again". I think we have the obligation to remit those dues. We've already paid per capita, let's give that gentleman or that lady the dignity as passing on as an Elk member. Remit the dues for them. If they're in Veterans home now you can do double duty, you can adopt them as a veteran, complete your Adopt

80's now, more than likely pushing 90. Is he even at home?

How do you keep members? Low prices at the bar I don't think is the secret. You can go to any bar in town, in Coldwater, our Lodge, we can go to any bar in town and buy drink cheaper than we can buy at the Elks Lodge. So what keeps us members? It's the Activities. The Lodge has to have to a good variety and a good repetition of activities. One major activity a month. You have to give the people something, the members something to want to come down to the Lodge to participate. You have to get them engaged. When they're down there, now you have to talk to them. We see a number of members in our Lodge, as we recruit and as we work on delinquents, they start to come back, we haven't

a Vet Program, and you're retaining a member. That's the

charitable thing to do. We need to show that brotherly love.

seen them in a long while. I remember them by face from a dozen years ago, but I can't remember their name. We go up and talk to them. Candidates, after we orient them, they go back downstairs to have a Toddy, we go down and join them. We talk to them about the Elks. That next Friday night, when they come in for dinner, we make sure that they're seated with somebody and if not, we go and sit with them. We talk with them about the Elks. They don't know enough to ask a lot of questions. We have to provide the answers before they ask. They want to know who we are. They want to know what their responsibilities are. They want to know "What can we do"? We see the name, we wear the pin, we see the badges, and it's all very cool. We get the Grand Lodge Newsletter; there are a lot of neat things in there "What can I do to help"? How can I make this happen"? Don't be bashful with new members. Don't be bashful with anybody, it doesn't pay.

We were in Pasadena this last August for a football game. We stopped at the Pasadena Elks Lodge. You see them every New Year's Day, there are Lodge is right on Colorado Boulevard. They rent their Lodge to the TV stations and National broadcasters to film the parade from their balcony, from their grounds. That is their Major fundraiser a year. We went down to have dinner there two different times, the first time we were the only two in the dining room, and this is a good sized dining room. They have full menu. They have a bartender that's all dressed up in a nice little bartender outfit, very personable. They have a professional waiter in a black tuxedo: he's got the cloth over his arm, takes very good care.

of you. Their members don't participate in their Lodge. They don't have any activities, they have the meal service. We were there on a meeting night and there were four officers that came in and ate with us and that was it. You have to have activities to get members down; you have to have activities to get members engaged. We stopped in Deadwood, South Dakota; their Lodge is on the second floor of a building they own. The only way that you know the Lodge is open, they have a BPOE sign hanging up on the second floor, if it's lighted you can go upstairs and have a drink, if it's out they're not open. We stopped in Pierre, South Dakota, at the Teddy Roosevelt bar. That Lodge found a bar that Teddy Roosevelt used to frequent when he'd go hunting in South Dakota. It was in storage unit someplace. They found out about it, they it and they installed in their building. While they were installing it they found a pair of Teddy's eyeglasses that were there. They've got those mounted up there. There are bullet holes in it where Teddy shot it up one night. There are so many interesting places to do. So many interesting Lodges to see in this country, that's something you teach the members at orientation, that that card will get into some of the most interesting places in the world, at least in the United States. There are stories in every Lodge. Those are the stories that you want to take to members so that they understand when they travel around, when they come the Ohio they can have a good time, they can stop, they can find the best places to eat, the best places to stay, the things to see, the areas to stay away from. That's the benefit of visiting another Lodge. That's the benefit of having a membership

card. That's one of the obligations that you have, to use that card to visit and to learn.

Every time I come to Ohio I take notes. I've got four pages of notes now I'm taking back to Michigan, not only to the State Association, but to individual Lodges. And Penny and I talk to every Lodge every year. We're down to 57 Lodges, so it's getting easier. As we get older it's harder to travel, but still we're going to make it. But we learn things here, we take it back and I have to thank you for that. You guys are very gracious, you're very warm, and you're very smart.

The end has caught up to me. I want to thank you for your time. We will talk more at the CLMS session this afternoon and I look forward to seeing more of you later today and tonight. Thank you very much.

PRESIDENT DYSERT: Is there any more reports to come before this Session? If not, I'll defer to Mary Carolyn Nichelson, who has to give away some prizes. Mary.

MS. NICHELSON: One prize. I'm going to invite Penny Geishert up; you can ask the gentleman behind you to hold your ticket, just in case she draws her own. Penny, as you can tell from Ed reference to her is quite an active Elk and she's been a State Trustee for six years. So she's done a lot and eventually, and we hope she'll be in, in 2023 their first female State President. Yeah, you go girl. Okay. We usually have to draw about three tickets until we get someone who is here. 926996. Anybody? 996. He should have bought that extra ticket. 775554. All right. I wondered if it was at

our table, because I told sold them first and if you were close. Thank you all so much. I had money in my safe that I sold from last night, but it looks to me like we grossed somewhere between \$1,700 and \$1,800. Thank you, Rose Durant. That's fantastic.

PRESIDENT DYSERT: After this we'll have the Memorial Service at 11 o'clock in this room and at 7:30 this evening the final Business Session, at which time the Elk of the Year, Elk Hall of Fame will be awarded. Excellent. Would everyone please rise. The State Chaplain, Brad, will lead us in prayer.

I now call upon Robert Essig for his Credentials and Registration Report.

MR. ESSIG: Here is my final Report for Credentials and Registration for the 2018 Annual Elks Convention here in Dublin: North Central District 89, Northeast District 100, Northwest District 131, South Central District 97, Southeast District 47, Southwest District 29, for the total of 493 registered, plus four Special Guests, gives us a total of 497 Members and Guests in attendance. This concludes my Report.

PRESIDENT DYSERT: Thank you, Bob. At this time I will call upon the Approving Member of the Board of Trustees, Lugene Ignaffo, who will present the Elk of the Year Award, followed by the Elk Hall of Fame Award.

MR. IGNAFFO: Thank you, President Dane. I'll tell you, it's great for the enthusiasm I see tonight when I came into the room. You've had a trying year; I know I preached at every District, "Hey, I need applications". I did get some responses, but then I really got some applications. Great applications. All outstanding Elks, men, women, Elks, and members. It makes the job hard. I think "God, now what do I do, I'm a nervous wreck? Look at this". But anyway, as my duty continued I decided I'd compile a Committee together, a couple of Elks Members, a non-Elk member, and we sat

down and we went to work. The lady looked at me and she says, "Boy, these guys do a lot." I said, "Yes, but it's just an average year for an Elk." Got a smile out of some of them though. So the Committee members, they finally, they brought me back a couple of names and I kind of sit and I bickered and I talked about it, and I thought "Wow, Okay. Now is the decision time."

But anyway, it was not easy, there were a lot of great applications, and I'll tell you, Ed, next year I know you're going to have a hard job, because I'm turning the leftovers to you. He attended the local Lodge meetings, District meetings, and State meetings near perfection. We've heard many times "Elks Care, Elks Share". So what was he to do, done locally, this past year, he has shown he cares about being loyal to the Lodge and carried it in the participation of 28 events and projects. Skills and dedication to the Lodge and community has been the new times in his life.

One of his favorite opportunities as an Elk, because he feels new members need to truly understand what it is to be an Elk. He made it his personal mission in helping with activities in numerous opportunities. He had a passion for cooking and keeping his self busy in the Lodge. In the past year he held six Sunday Wing Days and Chaired the Mother's Day Brunch event and hosted our Bike Run Breakfast. He helped with our United Way Fish Fry and ENF Spaghetti Dinner. He offered opportunities in supporting the Elks National Foundation Project by holding ENF fundraisers at the Kroger Marketplace, where he helped set up and tear down. Time was never of the essence to him, he had nothing but time and all day to make sure the job was done right. He helped for the ENF Beacon Grants in providing 420 schools with shirts and handed them out amongst the city and the Rally in the Alley.

He helped set up and distribute and clean up and tear down all the tents.

The youth in the community is very important to him. He was there for the Trick or Treat at the Courthouse Square for Halloween. He helped in setting up and tearing down again. And then the next thing in his heart was at the Special Olympics. He attended the area six times in helping with all the events and making sure the athletes and lunch and concession stand. He was there for our local Hoop Shoot and he included helping and set up and tear down.

With further adieu, it gives me great pleasure to announce the Elk of the Year, Past District Deputy Grand Exalted Ruler, and a great friend, Mr. Larry Wise.

Larry, would you like to make a comment, please.

MR. WISE: All those of you from South Central know
I was never very shy when I was District Deputy; I probably
got on my soapbox way too many times. I look out and
see all these red coats and I just have the urge to talk about
membership. But seriously, this means a lot; it's quite a
surprise, and thank you.

MR. IGNAFFO: Now, onto the next one, which we've all been waiting for. This gentleman was invited into the Elks in May of 1967. He immediately became active in all Lodge activities. He was awarded Elk of the Year in 1978. He served as Exalted Ruler in 1988-89. He is the current Secretary, which he has served at the position for God only knows, 39 years. He also spends an ample amount of time completing his secretary duties and also spending many hours

in the general maintenance of the building before retiring and almost committing his wake up hour to the Elks.

He worked and retired from the Van Wert Police Department for over 33 years. As a Patrol Officer he then served as department's Administration Officer, he provided programs for the schools, such as D.A.R.E. in the community. It was not uncommon to have a young person believe that he was right up there with Santa Claus and the Easter Bunny. He also served for 21 years in the Ohio National Guard and was the food service sergeant during that period of time. His mess won various awards in their outstanding achievements. Though there was much of his work for the Lodge he has been able to assist in creating a better understanding of what Elks means to a community. He has used the Elks Grants, which has applied and strengthened the community. He came up with the idea of the Gratitude Grant, along with part of the Promise Grant to create Elks Day at Camp Clay. The local YMCA has a camp on the edge of town, which is the Aquatic Park and splash pad. The Lodge promotes this day in allowing the youth to come for free. After an Elk has done all these activities for many locals and businesses and followed to provide free days at camp. He also works in the D.A.R.E. Program to keep involvement with the Elks, assisting treats for the daycare and attending and arranging meals for the graduating parties for some of those and other organizations.

Through this period of time in which we were building our new Lodge facility he gave many hours towards this activity. His assistance was needed to be done for snoring and

moving things and sorting to make them all where he wanted. Sorry about the snoring. Sorry.

His love for Elkdom in Van Wert is apparent. As we walk in his shoes for a period of time, you will find him at the Lodge changing light bulbs, unplugging the bar sink, cleaning out air vents, straightening out the patio, and cleaning up the parking lot after a rental event. He makes sure that the American Flag is in good condition and replaces it when needed. He volunteers his cooking abilities when needed in the kitchen and he also assists at various banquets and volunteer hosting and serving when needed.

He is a member of the Van Wert Lodge. He serves on the State Board as a Chairman of Reunions and Registration or not Reunions and Registration Conventions and Reunions. He works diligently and well and it is hard to do his job, never leaving a stone to be unturned. He has served the District as Chaplain three times and for over the 30 years District Calendar Chairman for two years and serving as District Secretary for two years. He has also served the Grand Lodge well. He does he was the District Deputy Grand Exalted Ruler for the West Central District in 1997-1998. He has served three times as a Special Representative. So with random acts of generosity and in the community and his love for the Elks and his devotion towards making it a goal to make the perfect society of what an Elk is. It gives me great pleasure to introduce to you the Elk Hall of Fame Winner, my friend, Mr. Mike Stanley.

MRS. STANLEY: I got you.

MR. STANLEY: What an honor. What an honor. I come home from the Lodge and I do this stuff and she says, "Why are you doing that for? That's not the secretary's job". And I go "Well, somebody has got to do it. It needs done". So I love the Elks and I just I thank you from the bottom of my heart.

MR. IGNAFFO: I would just like to say to all Exalted Rulers for the upcoming year, I know Ed is going to preach at you, please, if you have a member in your Lodge that is deserving of the Elk of the Year on your local level at your Lodge, he's deserving to have that application entered at the State level. So thank you again.

MS. HAWSE: Thank you, President Dane. Earlier today we held our full Ritual Contest, we held the 11 O'clock Toast Contest, The Flag Charge Contest, and the Ritual Contest. At this point in time I would appreciate if all the judges would please stand and be recognized.

with our awards, but if would you like to come down here by me, Sue has graciously offered to be our little runner, we won't make you do that.

We will begin with the 11 O'clock Toast. We have held this, I think this is, like, our third or fourth year, and the 11 O'clock Toast can be performed by any member, PER, ER, or any member, any officer, any member. We had 7 contestants today. And it is my pleasure at this point to tell you who the winner was. With a score of 95.728, Mr. Todd Daquino from Kenton No. 157.

The next contest was for The Flag Charge, which is the portion that the Exalted Ruler normally does towards the very end of the Ritual. Again, this is open to, ER's, PER's, Officers, and any members. We had four contestants today. With a score of 95.660, the winner was Mr. Todd Daquino from Kenton Lodge No. 157. Congratulation, Todd.

All right. We now will begin with the full Ritual Contest. An award will go to each of the winning officers, to the winning team, to the coaches of the winning team, and then to the officer that scored the highest. We will begin with the Inner Guard, with the score of 93.870, Ms. Gina Hoelscher from Kenton 157. For Chaplain, with a score of 94.877, Mr. Dave Heuser from Elyria. Our Lecturing Knight scored 94.953, and it's Mr. Derek Kaufman from Kenton No. 157. Our Loyal Knight scored 94.278, and it's Mr. Dustin McCullough from Kenton 157. Our next award goes to the Leading Knight, with a score of 93.887, Mr. Ignatius Todd Daquino, from Kenton 157. Our Esquire, with a score of

93.667, Mr. Michael Sturgeon from Kenton 157. And our Exalted Ruler, with a score of 91.168, Ms. Elisa McKinley from Kenton 157.

At this point in time, I would like to have the Exalted Ruler from both Kenton and from Elyria come forward to receive the team plaques. So Ms. Elisa McKinley and Mr. Dean Robinson.

The team award will go to I'm sorry with a score of 96.680, to Kenton 157. I'm not sure it's not bigger than you are. And our coach awards go Coaches Awards go to the coaches of the winning team, Mr. Dave Beazley and Mr. Jerry Haudenschield.

The next award is for the High Scorer of any of the contestants. The All State Award goes to the score of 94.953, Mr. Derek Kaufman of Kenton Lodge No. 157.

Lastly, we have the Virgil Judy Award. And before it's presented, I call upon Mr. Lugene Ignaffo to say a few words about the award.

MR. IGNAFFO: Thank you, Jill. For those who know Ritual, and I'm going back a ways when I first started in it, we had a gentleman that had more passion for Ritual than I ever thought one person could ever come up and have. But anyway, we got up there and my first introduction to him, he says, "Young man, you're going to do it this way. No if, and, butts, or ours, you're doing it this way". So anyway, I listened to him. Got me through the first couple years and then we butted heads again, you know what "Young man, you're going to do it this way". With his persistence and the dedication

and love that he provides to the Ritual he helped produce a National Championship Team for his love. He traveled to Kenton every week, always an open invitation, "Young man, would you like to go with me"? But you know what, I was persistent, I stuck around. He's a great friend of mine. No one in this world, that I know today, had a greater love for the Ritual than Virgil "Jiggs" Judy. It is my honor and pleasure to present the Virgil "Jiggs" Judy Award to Kenton.

MS. HAWSE: The traveling trophy can get picked up by the Kenton Lodge after the meeting. Thank you. And, again, I appreciate everybody's work today, everybody's efforts in the contest, and, again, on Sue's behalf I'm going to challenge each and every one of you to prepare for next year.

I would be remiss if I did PRESIDENT DYSERT: not mention a few words about Virgil Judy. I'm old enough to remember it being I couldn't call myself a contemporary, but I just about the same time Virgil was in his heyday, and back in the day when all the judges traveled across the state to various Districts you stayed in the home of one of the Ritual Judges. We didn't stay in the motel, we didn't get any expenses, and I stayed at Virgil's house a couple of times being in the District to judge a contest. And when the PER Association first started getting legs Virgil was instrumental in producing the by-laws and the Ritual. And when you see the service to the installation of officers tomorrow, almost all of that is Virgil's work. And computers were just coming into being then, Virgil would instruct me on the computer and he would send me the pages that he would generate. I would copy them and print

them and bring them to Columbus. So as Lugene said, he was a great teacher, he was a great leader, most of all he was a great Ritual man. I will miss him and I did this. Thank you.

Now, well, we're getting close now. I looked at this time I would like to introduce Past Grand Exalted Ruler James L. Nichelson for any remarks he may have.

PGER NICHELSON: My wife, Mary Carolyn. Hey, don't we clean up nice? Don't worry, in a few moments it will be T-shirts in the hospitality rooms. I would like to congratulate Dane and Jodee on a wonderful year. You know, he was thrusted into this position, and if you know Dane, he would not do so without a word or two of something or other. But despite his normal proclivity to perhaps to complain about that, he has followed through with great joy and with a lot of energy, and with Jodee behind him he's done you a wonderful job. And you know, Nevin, there's something about a farm boy from Hardin County that I just appreciate. And I give you all the best from all of us. We know that you are well prepared, you and Deana are going to do a wonderful job in representing the Ohio Elks all across the state and also in San Antonio, I'm sure. All our best to you guys.

I'd like to explain to you that we have Doug Schiefer, who because he has completed his second year as Chairman of the Fraternal Committee, is going off that Committee. It's the way it happens at the Grand Lodge level. But he has been gracious enough to accept an appointment to Activities Committee and will continue at the Grand Lodge level, Doug and Julia. And, Mike Iddings has gone on Ritual and has done a fantastic job for us. You know, he has been instrumental in talking them into considering the possibility of extending the Ritual Contest to include those charges. And so I will tell you that Michael will be continuing on the Ritual Committee. Michael, you guys. There you go.

I don't want to take any more of your time, because we have some a lot of good partying to do. But we have a couple of very special guests with us this weekend from Michigan and Ed Geishert and Penny have doing a yeoman job in educating us and helping us with membership, helping us with CLMS, and so we would be remiss if we did not recognize them one more time and ask Ed to come up here and say hello.

MR. GEISHERT: And I remember specifically I was told I would not have to speak this evening.

PGER NICHELSON: No, I said one word.

MR. GEISHERT: I said it.

UNIDENTIFIED SPEAKER: OH.

It's been a great whoa. Ouch. MR. GEISHERT:

UNIDENTIFIED SPEAKER: Go Blue.

MR. GEISHERT: Seriously, it's been a huge time down here. Penny and I love Ohio Elks, not so much the Buckeye portion of you, but the rest of you. You're really great people. We made a lot of great friends down here. We've enjoyed our time. I hope we've been able to impart a few ideas to you. We sure learned a heck of a lot from you and I guarantee you we're going to take it all back and make Michigan use the lessons we've learned down here. You've been a great inspiration to all of us. Thank you, very much.

Lead by example. Heavenly Father, you've led us and we ask that you protect us and guide us and always get us home safely. In your name, we all say, Amen.

MR. TAYLOR: 30 years ago tonight another Marysville 1130 member took the same exact oath of office I just took, Mr. James Payne. Hopefully, we'd thought Becky would be here tonight, but the love of Becky and the Jim Payne family is why I am standing here. And I would be wrong if I didn't say thank you, and I have it in the front row, my role model, the Past Exalted Rulers, they are in their green coats, one is dapper a little bit better though, I want to say to

be a competition under 360, under 750, and higher. Hold a fundraiser, it could be for a current event, it could be for Ohio's next Grand. We're in line hopefully in four years. Hint. Hint. Doug, get busy. It could be for MS. It could be for CP. It could be for scholarship. I don't care. But what I do care about is what you saw on the State of Ohio Pin that you saw out there, a T shape. "Talk Elks Everywhere". "Talk Elks Everywhere".

There will be a \$250 prize recognized by our Public Relations Committee and our website and some of the Officers who sit on a Committee to select our best "Talk Elks Everywhere" event this year. It will be awarded next April. There's challenge one.

Many times, and why I pick that theme, I wondered what do I do? Do I go with I do, or do I? These are to be called an Elk. Or make me, Chris Skinner, wherever you're at in the crowd, make me one better Elk. You know what? Better than what? I had a person in church say to me, "You're one of those big game hunters, aren't you"? And I looked, and I looked at him, I was like, "What are you talking about"? He said, "The Elks". And I thought "What a misconception, it's time to start talking Elkdom". It's time to start talking. That same individual later came over and donated blood at our Lodge with the Red Cross drive. If you've got a youth program, then it's time to let those parents have something to do, besides just drop off their kids to Antler meeting. "Talk Elks Everywhere". It will make a difference in your home Lodge. It will give you a big resource pool to help get volunteers. It will give you a resource pool where you can give funds. But more importantly, it will give you a group of people that understands how, pardon my French please, damn good it feels to be an Elk. Yes. Damn good. We need to partner up as a cause. We need to make people aware. ENF has all kinds of Grants, all you have to do is go online. And if you can't figure out how to get online, Ohioelks.com. If you want to go straight to National, Elks.org. Please go onto our website and go onto your website with someone who is not an Elk and let them see the programs we have, the opportunities we have, and the ability to make a difference in our community.

This year you will see the Endowment Committee take full control of the Angel Project. Money to be put away for the future so that Elkdom can give more to our communities. That's how we make a difference. That's how we let people know that the Elks are more than just a 12 ounce curl or a left-handed or right-handed throw back and to say thank you for the end of the day. It's important that people understand

we've got lots to offer and that we care and we will share.

Ladies and Gentlemen, you saw the pins and they have different shapes. You saw a round pin for a lady that doesn't have the ability to get up and run. Of course, she didn't like to run to start with. But my bride, my bride will tell you that color wheel, it's because there's lots of different colors of Elks. There's lots of different attitudes and there's lots of great people, besides the fact she taught art and she made the color wheel, but for somebody that's colorblind, it's just a lot of circle. When you look at the Buckeye pin I'm being proud to be Buckeye, but I'm more proud of the fact that I am an Ohio Elk and that makes a difference.

The other pin you see out there, and it has a "T" on it, it's because we need you and we need your support to purchase your CP pins. You're Committee works very hard for you. You'll notice on that pin there are four different types of kids because CP isn't prejudice. CP doesn't care whether it's a male or a female. But the day when the angel up above gives us guidance and protection where we can throw away the crutches, where we can throw away the walker aides, where we throw away the wheelchairs, then by God we did our job promoting and stopping CP. Please, get involved, become a part of it.

To all my State Chairman, thank you, I really appreciate the fact that you stepped up. I gave you some charges, because I thought we needed some direction. And I say to you "Lead us, Lead us". That will make the difference.

I have six people in the audience I'd like to recognize,

they'll be going in as District Deputies when we go to Texas. Mr. Rod Hotte is not here, from Wooster, he's in a wedding. That's okay. We'll get him in Texas. Northeast, Barry Harper, Willoughby/Cleveland, please stand. Mr. Ron Yaw. from Defiance 147. Okay. The next gentleman, Mr. Gary Stevenson, from New Lex Lodge 509. Mr. Michael Buchanan from Wellsville Lodge 1040. Mr. Ron Buxton from Lebanon Lodge No. 422. Ladies and Gentlemen, they're our District Deputies. They have the responsibility to the National level, but more importantly, they got responsibility to the fact that you aren't a National member yet, but in your heart you're always an Ohio Elk. We wish you the best of luck, we're here to support you, and if you don't do your job right we'll let you know. You can sit down.

Ladies and Gentlemen, your direct contact individuals are your DAC's. At this time I'd like to recognize all six DAC's for this upcoming year. Mr. Rob Nixon, from Ashland Lodge 1360. Give him a round of applause. From the Northeast, Mr. Jim Vasey, Lakewood Lodge No. 1350. From the Northwest District, Mr. Todd Cannode, Kenton 157. From the Athens Lodge, Mr. Dave Williams, and that would be Lodge No. 973. Jeff Warner, from New Philadelphia Lodge 510. And our final DAC is Dan Williams from Wilmington 797. Ladies and Gentlemen, show them our appreciation.

I can't say it enough that it's not about Nevin. And I can't say it enough about how strong I feel about Elkdom. But what I can tell you about Elkdom is, Elkdom is here, it's what you want to take out of it. Because if you don't take it out of here,

To Mr. Michael Stanley, as the Hall of Famer. Congratulations to Mr. Larry Wise, Elk of the Year, congratulations. You exemplify what Elkdom is. Live hard, day in and day out giving and not asking for what's in it for me. Ladies and Gentlemen, let's show them a little more appreciation. Our two Winners.

There were some changes you saw earlier tonight and you're going to see a few more this year. They aren't all my ideas and I'm okay with that, because it's not about me.

At this time, I'd like to bring to the podium, he's going to talk to you for a few quick seconds about the Ohio Elks Charity Tickets, Mr. Lloy Skillicorn, and I believe he has something he wants to talk about. Lloy, the floor is yours, take your mike. Here, take the mike. Okay, while he's getting that, if your District doesn't have an Ohio Elks Charity Ticket volunteer, were looking for applications in a couple Districts, we'd love to have your help, because this is a way for you to put money into your own Lodge and to make a difference for the charity projects in Ohio. Lloy, take your mike.

MR. SKILLICORN: President Nevin, I'd like to present to you from the Ohio Elks Charity a check for \$35,594.

PRESIDENT TAYLOR: Talk to them real quick.
MR. SKILLICORN: Starting next year, each District
Ohio Elks Charity Chairman, you're going to be responsible

MR. TAYLOR: Thank you. Those winners will be chosen at the end of this session. They'll be posted right over there. You're welcome to stay in here. When this session is over you've got your chance to go right next door. There's still food. There's still beverage. And South Central, get over there, Northwest, North Central, Northeast, Southeast, Southwest, get over there. Don't go back to that back hall, get over there and do that, otherwise we got to carry it home and Marysville 1130 doesn't want to do that. They don't want to do that.

My third challenge, I mentioned it earlier to you, is that we were going to do some things different.
